# TRANE INTERIM VARIANCE PRODUCT NOTICE

It's Hard To Stop A Trane.

This furnace is being sold pursuant to a product variance granted by the South Coast Air Quality Management District's hearing board.

This interim variance went in to effect October 28, 2019 and extends until December 3, 2019. For more information regarding this variance, please see the information below.

### WHAT CAN I SELL AND INSTALL?

For installations between 4,500 and 5,000 feet, non-compliant models that are allowed for installation are limited due to existing, comparable furnace offerings that are complaint with Rule 1111.

The charts to the right detail which Trane/Ameristar furnaces may be sold.

## **NOTICE AND DOCUMENTATION:**

In accordance with the interim variance ruling, the sales and installations of non-compliant furnaces must be recorded, and information must be made available for South Coast AQMD review upon request. Please see your distributor for information regarding what details must be provided with each installation.

# **MITIGATION FEES:**

Unit mitigation fees must be paid to the South Coast AQMD for each non-compliant furnace installed above 4,500 feet.
